BOARD MINUTES

Motion: That the Board of Directors approve the minutes of the May 2024 Board Meeting.

FINANCE REPORT

Committee update discussion by ChaChanna Simpson: NEST coffers stand at \$75k. The down payment cost to reserve the Queensbury Hotel in Glen's Falls, NY for 2025, 2026 & 2027 was \$7,500 for NEST Sharing the Fire.
