### **BOARD MINUTES**

### **DEVELOPMENT COMMITTEE**

Discussion: The committee is working to create opportunities to fundraise through sponsorship support and grants that align with NEST's mission.

Committee update discussion by Jim Brule and Cris Riedel: 700 people have joined WVSG with more asking to join the guild. The guild has clarified its purpose to develop storytellers. There is also a change to sharing posts on the guild's Meta (Facebook) page to one per week.

### **OUTREACH COMMITTEE**

Discussion: Preparation for the Speak Peace concerts in September is moving ahead. Linda Schuyler Ford is looking for tellers with stories 7-12 minutes in length for the virtual concert on September 17th. There is a \$25 honorarium. The Glens Falls Speak Peace concert at The Wood Theatre is now managed in partnership by Katie Knutson, Jim Brule, Denise Page, and Jezrie Marcano-Courtney.

Action: Katie will create a punch list of items for completion by the group.

And, a new member virtual showcase is scheduled for November, an opportunity to get introduced to new tellers with NEST and their work.
